APPLICATION FOR MEMBERSHIP – NOTES

Details of CIRM membership, fee structure and procedures are set out in CIRM’s Articles of Association and Rules which should be read in their entirety before signature. New applications are approved at the sole discretion of CIRM’s Board of Directors whose decision is final. Criteria for membership are applied as follows (as noted in the CIRM Rules):

Full Membership: open to any private organization or company being a corporation which has a separate legal personality, is in the manufacture, service or operation of maritime electronic devices and associated software applications generally and who are not subject to government control. Full members are afforded full voting rights and agree to be Members of the company for the purposes of UK Company legislation. Applicants will not be able to exercise the right to vote until the Board of Directors approves them as a Full Member.

Associate Membership: open to any organization or company being a corporation which has separate legal personality as noted above, which has an interest in the field of maritime electronic devices and associated applications but does not comply with the full membership criteria because they may be subject to government control. Associate members have no voting rights within the CIRM community.

Note: Should ownership of the company signing this application form transfer to another company by way of purchase, merger or similar, this membership (if successful), will not automatically transfer to the new company, but will be subject to the new company meeting the relevant criteria and to the approval of the Board of Directors.

Fees explained: A system of **multiplying 'units'** is used to calculate membership fees. One unit is currently set at **£875.00** (plus VAT where applicable). This figure is reviewed annually by the Board of Directors and then approved by the Full Members at AGM.
